2.0 Scope of Work:

The following Facilities mentioned below should be available to the employees (expatriates)

Primary procedures, tests and medications given as treatment deemed necessary by physician while in the clinic (IV fluids) will be covered.

- 1) Tests, secondary procedures and specialized meds will be covered
- 2) Entitlement to one free full annual medical per year.
- 3) Consultation, treatment and medications for chronic issues will be available to the employees
- 4) Exit evacuation treatment arranges flight, a flight crew and an accepting appropriate medical facility.

The annual physical includes:

- Standard medical forms fulfillment.
- CBC, Chemical, Lipids.
- Urine.
- EKG (if deemed necessary)
- Pregnancy Urine Analysis (for women)
- Basic Eye Exam
- chest x-ray

4) The patient will be escorted by a member of medical solution staff (a female may request a female escort) if it is deemed necessary for the patient to seen off site for consultation, assessment and/or treatment.

5) If overnight stay is deemed necessary, Transport and admission formalities should be done by the medication service provider.

Dental Care:

- Two checkups per year.
- Two dental cleaning per year
- Simple fillings
- simple extractions

Discharge Facilities:

- A Medicine/pharmacy procedure should be provided by the healthcare service to the patient

Special cases:

If it is deemed necessary for a patient to be seen by a specialist for an acute issue, Consultation with a specialist for a chronic issue should be available

Monthly healthcare Service as per mentioned scope of work, Exit evacuation in case of emergency if required,

3.0 Evaluation Criteria:

Quotes will be reviewed and evaluated by a technical committee according to the following selection criteria:

<u>Criterion</u>	<u>Relative Weight</u>
1. 24/7 Emergency Service	50%
2. Valid Business License	10%
3. Cost	40%

4.0 Quote Content Requirements:

1. The cost of any medication service will be included of 2% service tax as Internews Network Afghanistan will deduct BRT Taxes and submit it to MOF per Article 72 of Afghanistan Tax Law.”

2. The Medical service provider should provide a 24/7 365 days per year service at all costs
3. Internews Network Afghanistan will do four months initial contract and with extension yearly if our staff agreed of provided services.
