- b. All pages of this RFQ should be signed/stamped by Transportation Company.
- c. Attach copy of previous agreements your transportation had with any other organization for the same services (if any).

#### **Delivery time**

IOM will sign LTA with vendor and as per release order and PO they will provide us the transportation services.

# Transportation facilities to be provided under following conditions:

- **1)** The offered prices should include the transportation cost of the IOM and WFP standard packages related to the specific beneficiary and the beneficiary's baggage.
- **2)** The company should not ask the transportation cost of IOM beneficiaries personal belongings with maximum 20 kg weight.
- **3)** The company has the full responsibility of safe transportation of the persons with specific needs
- **4)** In case the bus gets technical problem; the company is obligated to change the bus immediately and avoid waiting of the returnees on road.
- 5) The company is obliged to avoid changing the assigned seats
- 6) The company is to drive according to Afghanistan traffic rules and avoid high speed
- **7)** The company should present the bus at IOM transit Centers at it's convenient time although the number of beneficiaries is low, one or two.
- 8) The driver and cleaner should take special care of elders, patients and physical disable persons, considering their problem the driver is to stop the bus.
- **9)** In the case of accident/or any other issue (such as security problem, unexpected stop), the company should inform immediately IOM Office.
- **10)** The nominated transportation focal point should be present in KTC in the night during the transportation and in the day for receiving the list of beneficiaries.
- **11)** The transportation company should provide separate unit price as per bus model (303, 404);
- **12)** The transportation company can't change the BUS model.
- **13)** For any unjustified delay in transportation, the company should either provide food or pay the cost of food for beneficiaries in KTC.
