- c. Attach copy of previous agreements your transportation had with any other organization for the same services (if any).
- d. Attach a copy of insurance letter for passengers
- e. IOM reserves the right to award contract to one or more vendors and split Goods/Services between multiple vendors in any combination as it may deem necessary and appropriate at its own discretion and in the best interest of IOM.

Delivery time

IOM will sign LTA with vendor and as per release order and PO they will provide us the items

Transportation facilities to be provided under following conditions:

- 1) The offered prices should include the transportation cost of the IOM (20-30KG) and WFP (120-150KG) standard packages related to the specific beneficiary.
- 2) The company has the full responsibility of safe transportation of the persons with specific needs, means that if there is a medical case and have need to stop the buses during the way to have a medical check with a doctor during the journey the company should wait for him and also should take care of his safety during the way.
- 3) In case the bus gets technical problem; the company is obligated to change the bus immediately and avoid waiting of the returnees on road.
- 4) The company is obliged to avoid changing the assigned seats.
- 5) The company is to drive according to Afghanistan traffic rules and avoid high speed.
- **6)** The company should present the bus at IOM transit Centers at it's convenient time although the number of beneficiaries is low, one or two.
- **7)** The driver and cleaner should take special care of elders, patients and physical disable persons, considering their problem the driver is to stop the bus.
- 8) In the case of accident, the company should inform immediately IOM Office.
- 9) Including IOM and WFP standard assistant packages the company is obliged to allow 20KG weight per person or (with single ticket price)
- **10)** The company should not use as public cargo, means that the company should not load extra goods in their buses which uses for IOM beneficiary's transportation.
- **11)** If the company is unable to provide transportation due to any company internal problems the company is obliged to bear additional food cost of beneficiaries staying in IOM TC.
- 12) In case the company is not able to transport beneficiaries from ZTC due to the company's failure, all charges like food and any other unexpected cost occurs during the transportation gap, will be charged as penalty against the transport company. The total amount will be deducted from their payment settlement.
- 13) In case of security or any other concern/problem with road (rugged way) that non of the transport company is ready to transport its passengers by 404 type of buses from Nimroz to the provinces listed above, then IOM will allow the company to use 303 buses as a temporary solution until then the problem is solved and or other companies start transporting passengers by 404 model of buses to the target destinations.

Prices

All prices should be in AFN inclusive all charges and according to the local market.

Payment

Payment should be done in AFN by Wire at the end of each month.
